Alltel Communications, Inc. (Alltel), by and through its undersigned counsel, and pursuant to Rule 25-22.006, Florida Administrative Code, and Section 364.183, Florida Statutes, files this Request for Specified Confidential Classification, and states as follows:

1. Contemporaneous with the filing of this request, Alltel has provided responses to Staff data requests in this proceeding.

2. Response to Staff Data Request 36 contains proprietary confidential business information of Alltel. Pursuant to Rule 25-22.006(4), Florida Administrative Code, Alltel files this Request for Specified Confidential Classification of the proprietary confidential business information in the response.

3. Section 364.183, Florida Statutes, provides an exemption from the public disclosure requirements of Section 119.07, Florida Statutes, for "proprietary confidential business information." Under Section 364.180(3)(e), Florida Statutes, "proprietary confidential business information" includes "[i]nformation relating to competitive interests, the disclosure of which would impair the competitive business of the provider of information. In this case, the information provided by Alltel contains sufficient information such that its competitors would be able to determine the number of Alltel wireless customers per wire center.


4. The information described above and provided in Response to Staff Data Request 36 is competitively sensitive information of Alltel and the public disclosure of such information would impair the competitive business of Alltel and provide a competitive advantage to competitors in the telecommunications service market. Alltel maintains this information as proprietary confidential business information which, if publicly disclosed, could be used by competitors to harm Alltel's competitive interests. The information for which confidential classification is sought is intended to be and treated as private and confidential by Alltel, and has not been disclosed publicly or otherwise. Accordingly, the information should be determined to be proprietary confidential business information pursuant to Section 364.183(3)(e), Florida Statutes, exempt from the public disclosure requirements of Section 119.07, Florida Statutes.

5. Attached as Attachment A are two copies of the redacted versions of Alltel's proprietary confidential business information included in Response to Staff Data Request 36.

6. Attached and included in a sealed envelope marked as Attachment B to this Request for Specified Confidential Classification are highlighted copies of the same documents containing the confidential information.

WHEREFORE, for the foregoing reasons, Alltel Communications, Inc. respectfully requests that, pursuant to Section 364.183, Florida Statutes, the Commission enter an Order declaring the information described above to be proprietary confidential business information that is not subject to public disclosure.

Data Request No. 5:

What facilities, planned or existing, does Alltel have in Florida in order to serve potential Florida customers?

Response:

Alltel's current network in the state of Florida consists of 757 digital CDMA cell sites and 8 switches located in Ft Myers, Gainesville, Jacksonville, Panama City, Pensacola, Pinellas, Tallahassee and Tampa. As evidenced in the five-year build-out plan, submitted to the FCC in anticipation of ETC designation, Alltel planned to build an additional 24 cell sites and expend in excess of \$26M to upgrade its existing facilities in 2006 in the state of Florida. The five-year build-out plan submitted under seal with the Applications detail Alltel's plans for 2007.

The average monthly bill for an Alltel Florida customer as of 9/30/2006 was approx. \$53. This includes monthly charges, toll charges, data services and other services provided by Alltel.

Data Request No. 9:

What is the average Lifeline customer monthly bill in Florida?

Response:

Alltel offers stand-alone Lifeline rate plans pursuant to 47 C.F.R. § 54.403(a). The standard Lifeline plan is available to qualifying customers for \$16.70 per month. The Lifeline Tribal plan is available to qualifying customers for \$1 per month. Additional airtime is available for \$0.45 per minute. Toll is available for \$0.40 per minute and roaming outside the Alltel home coverage area is \$0.59 per minute. The average Lifeline customers' bill can vary from month to month depending on the subscribers' unique usage patterns.

Data Request No. 10:

Does an Alltel customer have to sign a service agreement? If so, for what term? What are the terms and conditions? Is an Alltel Lifeline customer required to sign a contract or any similar agreements? Please provide an example of the standard agreement.

Response:

An Alltel customer is not required to sign a fixed term service contract unless the customer chooses to purchase the handset at a discounted price.¹ A customer that chooses to purchase the handset at a discounted price has the option of selecting a one or two year term contract. A customer that signs a fixed term contract and chooses to terminate service before the expiration of that contract will be subject to an early cancellation fee that is disclosed to the customer at the point of sale.

An Alltel Lifeline customer is not required to sign a fixed term service contract even if the customer purchases a handset at a discounted price. Alltel Lifeline offerings are pre-paid services, which do not impose contractual obligations.

We will not give you notice of any subpoenas or court orders related to your account or use of Services unless required by law. Information in our billing and customer care systems concerning your account and your use of Services belongs to us, and you have no expectation of privacy with respect to such information. You agree that we may release information we have about you when required to do so by law, to provide to third parties solely for the purpose of assisting us in providing any Service to you, or if we reasonably believe that an emergency involving immediate harm to a person or property requires disclosure. We may analyze your account and usage information and share this information with other Alltel entities to communicate with you regarding Equipment or Services that may become available to you. The traditional telephone market has changed dramatically since 1996. Mobile service providers such as Alltel bundle local, LD, and airtime usage into attractive service offerings. As a result, interest in "Equal Access" has diminished significantly. Even without equal access, a customer can access a long distance provider of his/her choice because the customer has the ability to dial-around.

Response:

“Partially served” means Alltel is not licensed to served the Rural LEC study area in its entirety. FCC rules define “service area” to mean the Rural LEC study area unless the state Commission and the FCC jointly redefines that term. In this instance the, Florida Commission may redefine the Rural LEC’s service area in accordance with FCC rule 54.207(c)(1) to include only those areas that are within Alltel’s licensed service area.

Referring to page 15 of the Application, the company indicates that the redefinition of the service areas “will foster competition and offer customers in the exchanges that are served by Alltel a competitive universal service offering.”

- a. Please identify where in either Section 214 or the FCC’s rules implementing this statute that a goal of USF is to foster greater competition.

Response:

The FCC, in paragraph 44 of its March 17, 2005 Universal Service Order, indicates that it will consider “consumer choice” and the “advantages and disadvantages of a particular offering” when determining the public interest. In a competitive market customers not only have more choices but competitive rates. The FCC has recognized that universal service can help bring more choices and competitive rates that are available in the urban areas to the rural areas of the United States.

- b. Please explain what a “competitive universal service offering” is and why it is appropriate to encourage such multiple offerings.

Response:

A “universal service offering” must consist of the nine-supported service identified in 47 C.F.R. 54.101(a). However, when these services are provided using different technologies customers are afforded distinct choices. Customers are therefore, able to choose a service provider and a service offering that best meet their communication needs. Clearly, the most attractive features of a wireless competitive universal service offering are the benefits associated with mobility and freedom to make calls within a larger calling area without incurring additional expenses.
