Enclosed for filing in the above-referenced docket is the response of Alafaya Utilities, Inc., (*Utility*) to Staff's fourth request for information dated September 5, 2006:

(1) On Schedule S-13 in the utility's 2005 Annual Report, Alafaya stated it presently serves 6,319 equivalent residential connections (ERCs) and will reach 8,571 ERCs upon buildout of its service area. Based on the MFRs, the 2005 13-month average net contributions in aid of construction (CIAC) ratio is 51.50% for wastewater. Also, the wastewater collection system amount is \$3,700,377 less than the wastewater CIAC.

(a) What is the utility's estimated buildout date?

RESPONSE: 2012. However, Alafaya does not possess sufficient information to accurately predict when, where, or at what density development will occur within the certificated service area. Please note that in determining the buildout date and date of reaching design capacity, the Utility relied on the data in

Schedules F-6, 8 and 10. This was done to maintain a methodology for determining equivalent ERCs compatible with that in the MFRs. Equivalent ERCs are calculated in the MFRs differently than they are in the Annual Report. Based on Schedule F-10 of the MFR, Alafaya served 7,033 ERCs. Buildout is reached when design capacity (100% U&U, excluding additional growth) is reached, which is 8,931 ERCs in 2012.

- (b) What is the utility's estimated date that Alafaya will reach its current design capacity of the utility's wastewater treatment plant?

RESPONSE: Please refer to the Utility's response to No. (1)(a). Additionally, it is important to point out that the existing two treatment trains are sized to meet buildout flow conditions. The limiting factor in the permitted capacity is effluent disposal of reclaimed water. Future capital projects are not designed to increase wastewater treatment capacity. Instead, they are intended to (1) expand reuse storage and pumping facilities, (2) expand reuse disposal capacity, (3) replace existing equalization tanks, (4) replace an existing digester tank, or (5) construct sludge handling facilities.

- (c) If buildout is projected to occur after 2013, provide the projected depreciable assets, land, accumulated depreciation, wastewater collection lines, CIAC, accumulated amortization of CIAC, and number of customers for the specific year-end that the utility will reach its current design capacity of the utility's wastewater treatment plant. In your response, provide a breakdown of each of these requested components by year for the calendar years 2005 through the year-end that its current wastewater design capacity is reached. In addition, provide work papers detailing all calculations and assumptions made in the utility's projections.

RESPONSE: Not applicable.

- (d) If buildout is projected to occur on or before 2013, provide the projected depreciable assets, land, accumulated depreciation, wastewater collection lines, CIAC, accumulated amortization of CIAC, and number of customers for

the specific year-end that the utility will reach buildout. In your response, provide a breakdown of each of these requested components by year for the calendar years 2005 thorough the year-end that the utility reaches buildout. In addition, provide work papers detailing all calculations and assumptions made in the utility's projections.

RESPONSE: Per conversations between the Utility and Commission Staff, the Utility was asked to calculate only an estimated rate base through 2010. Please refer to Exhibit (1)(d) attached hereto. The Utility assumed the same amount of CIAC and plant in service that was placed in service in 2005. It also included the proposed pro forma plant additions. Accumulated depreciation and amortization were rolled forward based on these plant and CIAC items.

- (2) On MFR Schedule E-4, Alafaya reflected its current miscellaneous service charges. Further, the utility proposed after hours charges of \$22.50 for initial connection and normal reconnection, actual cost for violation reconnection, and \$15.00 for premises visit. It is the Commission's practice to approve miscellaneous service charges (including initial connection, normal and violation reconnection and premises visit charges) for a water and/or wastewater utility as long as the amounts and conditions are the same as recent Commission decisions. By Order No. PSC-06-0684-PAA-WS, issued August 8, 2006, in Docket No. 050587-WS, In re: Application for staff-assisted rate case in Charlotte County by MSM Utilities, LLC, the Commission found that MSM Utilities, LLC (MSM) shall be allowed to increase its water and wastewater miscellaneous service charge as follows:

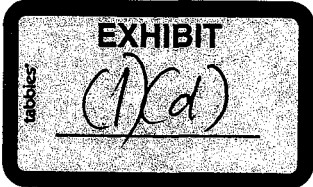

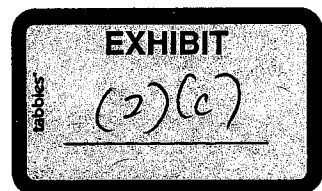
