



On October 3, 2006, BellSouth Telecommunications Inc. ("BellSouth") submitted a Motion for Clarification of Order No. PSC-06-0776-FOF-TP. On October 10, 2006, Quincy Telephone Company d/b/a TDS Telecom, Northeast Florida Telephone Company, d/b/a NEFCOM, GTC, Inc. d/b/a GT Com, Smart City Telecommunications, LLC d/b/a Smarty City Telecom and Frontier Communications of the South, LLC (hereinafter referred to collectively as the "Small LECs"), filed a Response and Cross-Motion for Clarification and Reconsideration.
