Dear Mr. Hoffman:

The Florida Public Service Commission has received your letter dated November 1, 2006, requesting an extension of time for Aqua Utilities Florida, Inc. (Aqua) to file its Minimum Filing Requirements (MFRs) to December 1, 2006.

By letter dated May 23, 2006, Chairman Lisa Edgar approved a December 2007 projected test year for Aqua, and established an October 10, 2006 filing date. On September 15, 2006, Aqua requested an extension to file its MFRs until November 13, 2006. Aqua's request was granted based on Aqua's desire to provide a complete filing and its assertion that the approved projected test year of December 31, 2007, would remain representative of the company's current operations.

While your request for a second extension to file MFRs is approved, any subsequent request may be rejected if the December 31, 2007, projected test year no longer corresponds to the company's operations. Please note, that all other aspects contained in the May 23, 2006, test year approval letter remain in effect. Therefore, the complete petition, MFRs, testimony, and filing fee should be received by December 1, 2006.
