The Department has reviewed the application by Town and Country Utilities Company for consistency with the Charlotte County's and Lee County's Comprehensive Plan. The Department finds that the development is consistent with the Charlotte County plan. It will not be consistent with Lee County's plan until the County amends their plan.

The proposed development is in an area of the Babcock Ranch known as Area 6. Area 6 is mainly located within Charlotte County and is comprised of 18,200 acres with about 4,100 acres located in Lee County. The applicant is expected to develop 19,500 residential units, six million square feet of non-residential, including hotel, office and retail use, golf courses and civic building to include schools, fire and police facilities and other county services. The Babcock Ranch Overlay District amendment that would allow the development to proceed in Charlotte County was adopted by Charlotte County and found to be consistent by the Department of Community Affairs. The Babcock Ranch project is currently proceeding through the Master Development Incremental alternative Development of Regional Impact process and through the Future Land Use Map plan amendment process with Lee County.
