Please accept this letter as a joint status report by Four Points Utility Corporation ("Utility") and the Island Club West Homeowners Association ("Association") (collectively, the "Parties") on their participation in mediation in an effort to settle this matter without having to resort to a formal administrative hearing. On October 12, 2006, the Parties participated in a mediation session before FPSC mediator, David Smith, in Lakeland, Florida. The Parties are continuing in their efforts to settle the matter. In order to allow the Parties to focus their efforts on settlement, the Parties respectfully request that the date for the Utility to file testimony and exhibits be continued from November 13, 2006 to November 20, 2006.

Modification of this deadline will not affect any of the other controlling dates that the Pre-Hearing Officer previously established. The undersigned has discussed this proposed schedule with FPSC counsel, Rosanne Gervasi, and is authorized to represent that FPSC staff does not object to the proposed schedule modification. Furthermore, the Association representative, Mike Flynn, has approved the proposed schedule and has authorized this filing.


