Section 364.183(3)(a), Florida Statutes, expressly provides that "trade secrets" fall within the definition of "proprietary confidential business information." Section 364.183(3)(e), Florida Statutes, further provides that "proprietary confidential business information" includes "information relating to competitive interests, the disclosure of which would impair the competitive business of the provider of information."

The highlighted information in Confidential Attachment A contains the anticipated monthly amount of flow through savings to QCC's Florida consumer and business retail intrastate long distance customers. If competitors were able to acquire this highly confidential detailed and competitively sensitive information regarding QCC, they could more easily develop entry and marketing strategies to ensure success in competing with QCC. This would afford them an unfair advantage while severely jeopardizing QCC's competitive position. In a competitive business, any knowledge obtained about a competitor can be used to the detriment of the entity to which it pertains, often in ways that cannot be fully anticipated. This unfair advantage skews the operation of the market, to the ultimate detriment of the telecommunications consumer. Accordingly, QCC respectfully requests that the Commission classify Confidential Attachment A and the proprietary confidential business information it contains as confidential.

QCC understands that the information at issue is exempt from Section 119.07(1), Florida Statutes, and the Commission will accord it the stringent protection from disclosure required by Rule 25-22.006(3)(d), Florida Administrative Code, until returned to QCC.
