Staff requests approval to make an oral modification to Issue 14 of Item 13 (Park Water Company) at the November 21, 2006 agenda conference. Staff has discovered a minor error in the recommendation sentence of Issue 14, page 25, of staff's Recommendation for Park Water Company. Staff failed to pick up last minute changes to the recommendation statement. The numbers shown in the staff analysis is correct.

This revision should be considered a typographical error as the appropriate adjustment appears on Schedules 3-B and 7-B, and is reflected in the revenue requirements and the proposed rates. This proposed modification does not affect any other Issue in this recommendation. The type and strike version is shown below:

Recommendation: The appropriate amount of rate case expense for this docket is ~~\$18,175~~ \$18,375. This expense should be recovered over four years for an annual expense of ~~\$4,544~~ \$4,594.
