Dear Ms. Bayo:

Verizon Business¹ requests that the Florida Public Service Commission ("Commission") cancel the certificates of its subsidiaries SouthernNet Systems, Inc. ("SN") doing business as an Interexchange Company (TI907), Telecom*USA, Inc. ("TUSA") doing business as a Payphone Service Provider (TE165) and MCI Communications Services, Inc. ("MCICSI") doing business as a Shared-Tenant Service Provider (TS185). This request is part of an effort by Verizon Business to streamline its business operations in a manner that will simplify administrative requirements for the company, regulators and customers. All other certificates for these companies will remain in effect.

SN as an interexchange carrier, TUSA as a payphone provider and MCICSI as a shared-tenant provider have no customers and provide no telecommunications services in Florida. Final Regulatory Assessment Forms for year end 2006 along with the minimum payments are attached for these companies.

¹ "Verizon Business" refers to MCI, LLC business units and certain other business owned by Verizon Communications, Inc. that serve enterprise and government customers. Verizon Business operating units provide enhanced services and local, long-distance and other telecommunications services domestically and internationally.


