JOINT STATUS REPORT

Orlando Utilities Commission ("OUC") and Progress Energy Florida, Inc., ("PEF") (collectively, "the Joint Petitioners"), pursuant to Commission Order PSC-06-0773-PAA-EU, jointly file this status report on their negotiations toward a new territorial agreement in Orange County and state as follows:

1. Pursuant to Commission Order PSC-06-0773-PAA-EU, the Joint Petitioners are required to file a joint status report with the Commission on November 30, 2006 regarding their negotiations toward a new territorial agreement in Orange County.
2. The Joint Petitioners hereby report that they are examining multiple alternatives and feel they have made progress in their negotiations toward a new territorial agreement. The Joint Petitioners are optimistic that they can reach a new agreement in the near future. The Joint Petitioners will continue to negotiate the remaining issues that they have regarding a new agreement and will, in any event, conclude their negotiations and will file a new agreement, if one is reached, on or before January 31, 2007.
3. Given the current status of the negotiations between the Joint Petitioners, the Joint Petitioners do not believe that any additional Commission action is necessary to assist the parties in negotiating a new agreement at this time.
