

BellSouth Telecommunications, Inc. ("BellSouth"), pursuant to Rule 25-22.006, Florida Administrative Code and Section 364.183, Florida Statutes, files this Request for Specified Confidential Classification.

1. On November 17, 2006, BellSouth filed the Surrebuttal Testimony and exhibits of Kathy K. Blake, Ronald L. Hilyer, and C. S. Pendergrass. BellSouth also filed a Notice of Intent as portions of the Surrebuttal Testimony and exhibits contain information that has been designated "confidential" and is proprietary to BellSouth.

2. Because the information provided in the Surrebuttal Testimony and exhibits of Kathy K. Blake, Ronald L. Hilyer, and C. S. 

**Explanation of Proprietary Information**

1. This information is proprietary and confidential business information used by BellSouth in conducting its business, and not commonly known by or available to the public. Specifically, this information contains confidential business and financial information, including, but not limited to, forecasts, and hypothetical situations.
2. This information contains confidential, proprietary business information of BellSouth. BellSouth strives to keep this information confidential and not publicly disclose the information. This information contains detailed budget, financial and strategic information for BellSouth. Disclosure of revenue accounting and business costs could give competitors a clear picture of the resources required to provide services. This information also includes vendor specific information, and/or, vendor specific prices negotiated by BellSouth. Knowledge of such resource requirements could harm the competitive interests of BellSouth and impair BellSouth's ability to contract for goods and services on favorable terms.
3. This information contains confidential, proprietary business information of BellSouth. BellSouth strives to keep this information confidential and not publicly disclose the information. Specifically, this information contains in service quantities and revenues broken down by types of service. If this information were disclosed publicly, it would damage the competitive interests of BellSouth.
