Accordingly, with this Memorandum, Docket No. 060727-TI should be closed.

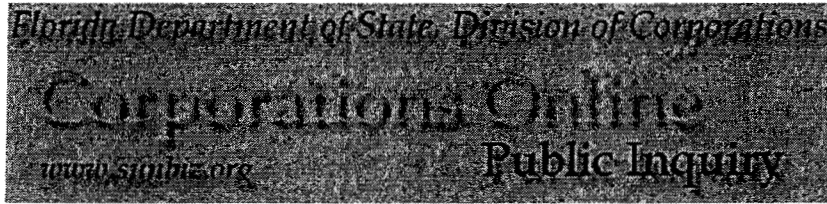
