

Timucuan Utilities, LLC ("Utility"), by and through its undersigned attorneys and pursuant to Section 120.542, Florida Statutes, files this Amendment to its Motion for Temporary Rule Waiver, and states:


1. On November 13, 2006, the Utility, in connection with its Application for Water and Wastewater Certificates, filed a Motion for Temporary Rule Waiver requesting a temporary waiver of certain enumerated Rules.

2. By this Amendment, the Utility requests that in addition to those Rules enumerated in its original Motion for Temporary Rule Waiver that the Commission also grant a temporary waiver of Rule 25-30.033 (1) (o), which requires a statement regarding the separate capacities of the proposed lines and treatment facilities in terms of ERCs and gallons per day.

WHEREFORE, Timucuan Utilities, LLC, requests this Commission enter an Order temporarily waiving the requirements of Rules 25-30.033 (1) (o), Florida Administrative Code.
