To Whom It May Concern:

We represent John Terry Lee, the duly appointed and acting Trustee for the bankruptcy estate of Southern Telcom Network, Inc. Please find attached a copy of the order appointing this office as the Trustee's representative, notice of the Trustee's appointment and proof of the case filing.

The debtor commenced its voluntary chapter 11 case on 20th April 2006. The case was converted to one under chapter 7 on 19th July 2006 whereupon all assets of the debt became property of the bankruptcy estate.

STN representatives indicate that STN was doing business in your state via a COA or SPCOA or like license granted by your agency. It has come to our attention that an STN representative, its President Kathy Robins, in October 2006, nearly three months after the case was converted, attempted to transfer the SPCOA of STN to another entity owned by Ms Robins.
