NOTICE IS HEREBY GIVEN that the Florida Public Service Commission has received an Amendment to Motion for Temporary Rule Waiver from Timucuan Utilities, LLC, filed December 11, 2006, in Docket No. 060741-WS, seeking to amend its original Motion for Temporary Rule Waiver filed November 13, 2006, by which it requested a temporary waiver of Rules 25-30.033(1)(j), (k), (m), (p), (r), (t), (u), (v), and (w), Florida Administrative Code.
