

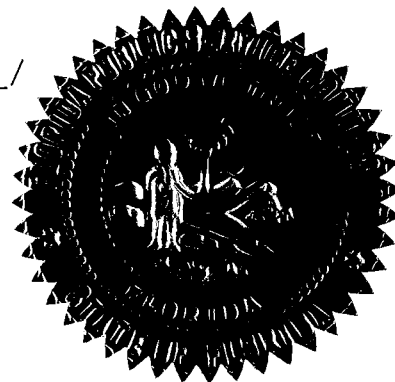

12 begins at the weatherhead," and change the word from
13 "continued" to "continues".
