As you are aware, Order No. PSC-05-1242-PAA-WS, issued December 20, 2005, in Docket Nos. 040951-WS and 040952-WS, approved the transfer of Florida Water Services Corporation's systems in Brevard, Highlands, Lake, Orange, Pasco, Polk, Putnam, Seminole, Volusia and Washington Counties to Aqua Utilities Florida, Inc. (AUFI). In the above-referenced docket, Aqua America, Inc. (AUFI's parent corporation), requested that the names of its remaining systems Alachua, Highlands, Lake, Lee, Marion, Palm Beach, Pasco, Polk and Sumter Counties be changed to AUFI. As part of the filing in the docket, all of AUFI's certificates were returned for possible amendment.
