

Enclosed please find Sprint Communications Company L.P.'s ("Sprint") Interexchange Carrier Flow-through Calculations for switched access expense reductions realized due to the December 19, 2006 BellSouth Telecommunications, Inc. Florida ("BellSouth") access charge reduction tariff filing pursuant to Section 364.163, Florida Statutes. As the calculations demonstrate, Sprint has reduced in excess of the amounts attributable to the BellSouth tariff filing.

Pursuant to Section 364.183(1). Florida Statutes, Sprint claims that certain information provided in the flow-through calculations is confidential and proprietary business information of Sprint that should be held exempt from public disclosure. 
