On February 14, 2007, Nocatee Development Company/SONOC Company, LLC ("Nocatee"), pursuant to Section 364.183(1), Florida Statutes, filed its claim that certain information provided in the Responses to Staff's Data Request No. NOC-1 contained confidential and proprietary business information that should be held exempt from public disclosure. Based upon our subsequent review of the documents, Nocatee has determined that one of the three documents is no longer confidential and that only portions of the other two documents remain confidential. Based upon this review, Nocatee has prepared revised redacted documents of the two documents still containing confidential information; the third document is not confidential.
