Dear Ms. Bayó:

By this letter, Verizon International Communications Services Inc. ("VICS") notifies the Florida Public Service Commission that it will discontinue its prepaid calling card service effective March 7, 2007. VICS, a subsidiary of Verizon, will cease operations on this date and will no longer be providing prepaid calling card services to the public.

VICS is a reseller of international calling services in Florida. VICS resells these services via prepaid calling cards subject to its filed tariffed rates. The calling cards are sold at retail locations throughout the state to end user customers. These cards have an assigned dollar value at sale.

Since determining that it will cease operations, VICS has begun an extensive effort to collect all prepaid cards that have been distributed to retailers but not sold to end users. Specifically, VICS has determined how many cards have been distributed but have not been activated or do not yet have any usage attributed to them. VICS has begun the process of collecting those cards and undertaking an auditing process to ensure that as many of the distributed but unsold cards are collected as possible. Once collected, these cards will be shredded and distributors will be refunded for their activated stock which did not have any usage.

With regard to cards that have been distributed and have usage assigned to them, VICS has developed a detailed plan to honor all cards by either providing customers with a refund for the full amount of the unused portion of any valid card or by providing credit allowing the customer to receive service from an alternative service provider. Customers will be informed of the procedures for receiving this refund or alternative service by calling the customer service number provided on each card.

This process will continue until December 31, 2008. VICS has determined that all cards that have been purchased or distributed will have expired by their terms by
