Dear Ms. Cole:

Enclosed for filing is the original and three (3) copies of a tariff revision filed on behalf of BellSouth Long Distance, Inc d/b/a AT&T Long Distance Service. This filing increases the Monthly Recurring Charge (MRC) by \$1.00 for numerous grandfathered residential service plans. This filing also revises the rate structure for the billing of the MRC for BellSouth® Basic Unlimited Value, BellSouth® Basic Unlimited Savings Value and BellSouth® Basic Unlimited II Value residential plans to combine this charge for inter/intrastate jurisdiction. The combined MRC will result in a total overall rate increase of \$1.00 for BellSouth Long Distance Customers who subscribe to these service plans. Customers have been notified of these rate increases by bill message.

Finally, this filing also combines the MRC for inter/intrastate jurisdiction for numerous residential service plans. The combined MRC will be unchanged resulting in no total rate change for BellSouth Long Distance Customers who subscribe to these service plans. The Company respectfully requests an effective date of April 2, 2007 for this revision.
