

**VERIZON ACCESS TRANSMISSION SERVICES' MOTION FOR LEAVE TO FILE
AMENDED TESTIMONY AND AMENDED PREHEARING STATEMENT**

Verizon Access Transmission Services ("Verizon") seeks leave to file amended versions of the Direct Testimony of Don Price, the Rebuttal Testimony of Don Price, and Verizon's Prehearing Statement. Amendment is necessary for two reasons.

First, it has come to Verizon's attention that the issue numbers used in its testimony and Prehearing Statement do not match the numbers in the Order Establishing Procedure. This discrepancy should be corrected to avoid any confusion.

Second, since Verizon submitted the documents at issue, the parties have settled two additional issues, designated as Issues 2 and 3 in the Order Establishing Procedure, so discussion of those issues is no longer appropriate. The amended versions of Don Price's Direct and Rebuttal Testimony and Verizon's Prehearing Statement, therefore, remove material relating to the withdrawn issues. Please replace the previously filed versions of these documents in the record with the amended versions.

For the reasons stated here, Verizon asks the Commission to accept the amended versions of its testimony and Prehearing Statement that accompany this Motion.


