AGREEMENT

This Agreement, which shall become effective thirty (30) days following the date of the last signature of both Parties ("Effective Date"), is entered into by and between RNK Telecom, Inc. ("RNK Telecom"), a Florida corporation on behalf of itself, and BellSouth Telecommunications, Inc., ("BellSouth"), a Georgia corporation, having an office at 675 W. Peachtree Street, Atlanta, Georgia, 30375, on behalf of itself and its successors and assigns.

WHEREAS, the Telecommunications Act of 1996 (the "Act") was signed into law on February 8, 1996; and

WHEREAS, section 252(i) of the Act requires BellSouth to make available any interconnection agreement filed and approved pursuant to 47 U.S.C. § 252; and

WHEREAS, RNK Telecom has requested that BellSouth make available the interconnection agreement in its entirety executed between BellSouth and MCImetro Access Transmission Services, L.L.C. dated November 5, 2006 for the state of Florida.

NOW, THEREFORE, in consideration of the promises and mutual covenants of this Agreement, RNK Telecom and BellSouth hereby agree as follows:

1. RNK Telecom and BellSouth shall adopt in its entirety the MCImetro Access Transmission Services, L.L.C. Interconnection Agreement dated November 5, 2006 and any and all amendments to said agreement executed and approved by the appropriate state regulatory commission as of the date of the execution of this Agreement. The MCImetro Access Transmission Services, L.L.C. Interconnection Agreement and all amendments are attached hereto as Exhibit 1 and incorporated herein by this reference. The adoption of this agreement with amendment(s) consists of the following:

2. In the event that RNK Telecom consists of two (2) or more separate entities as set forth in the preamble to this Agreement, all such entities shall be jointly and severally liable for the obligations of RNK Telecom under this Agreement.

3. The term of this Agreement shall be from the Effective Date as

set forth above and shall expire as set forth in Section 2, General Terms and Conditions of the MCImetro Access Transmission Services, L.L.C. Interconnection Agreement. For the purposes of determining the expiration date of this Agreement pursuant to Section 2 of the MCImetro Access Transmission Services, L.L.C. Interconnection Agreement, the effective date shall be thirty (30) days following the date of the last signature.

4. RNK Telecom shall accept and incorporate any amendments to the MCImetro Access Transmission Services, L.L.C. Interconnection Agreement executed as a result of any final judicial, regulatory, or legislative action.

5. Every notice, consent or approval of a legal nature, required or permitted by this Agreement shall be in writing and shall be delivered either by hand, by overnight courier or by US mail postage prepaid, or email if an email address is listed below, addressed to:

Unless otherwise provided in this Agreement, notice by mail shall be effective on the date it is officially recorded as delivered by return receipt or equivalent, and in the absence of such record of delivery, it shall be presumed to have been delivered the fifth day, or next business day after the fifth day, after it was deposited in the mails.
