Request for Permission from Department of Financial Services to Write-Off the Uncollectible RAFs

On October 20, 2006, Docket No. 060699-TI was established to address the cancellation of GST Net, Inc.'s intrastate interexchange telecommunications (IXC) Registration No. TI176 due to bankruptcy.

By Order No. PSC-06-1021-PAA-TI, the Commission granted cancellation of GST Net, Inc.'s IXC Registration No. TI005, effective October 20, 2006. The Commission further ordered that the Division of Administrative Services shall be notified that the unpaid Regulatory Assessment Fees (RAFs) shall not be sent to the Department of Financial Services for collection, instead permission for the Commission to write-off the uncollectible amounts will be requested.

Therefore, staff requests that the Fiscal Services Section take the appropriate steps to seek permission from the Department of Financial Services to write-off the uncollectible amount.
