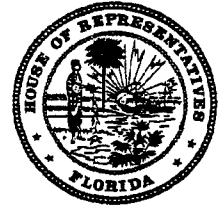

By this letter, I wish to correct an error in our Third Set of Interrogatories that I filed yesterday. In parts "b," "c," and "d" of Interrogatory 118, I inadvertently referenced "Interrogatory 115(a)." The proper references should have been to part "a" of Interrogatory 118. Accordingly, the corrected version of Interrogatory 118 should read as follows:

118. Affiliates

- a. Please identify all non-utility and non-regulated companies that Aqua Services, Inc. owns and/or provides services and/or products to, and describe the ownership and/or the services/products provided to these companies.
- b. For each company identified in response to part "a", above, explain if any costs from Aqua Services, Inc. and Aqua Resources, Inc. are allocated or charged to the non-utility and/or nonregulated company, the method of allocation or charging, and the amounts allocated or charged, by account, in 2004, 2005, 2006, and as projected for 2007. Provide the numerator and denominator of the allocation factor used to allocate the costs and the total costs to which the allocation factor was applied, by account. Provide the requested information in electronic spreadsheet format with all formulas and links intact.
- c. For each company identified in response to part "a", above, describe the services and or products sold during 2004, 2005, and 2006.


