Dear Mr. Jaramillo:

The purpose of this letter is to inform you that Movie, Television & Graphics Corp. d/b/a M.T.G.'s (M.T.G.'s) competitive local exchange telecommunications company (CLEC) Certificate No. 7773 was canceled effective November 16, 2006, for apparent violation of Final Order No. PSC-06-0600-FOF-TX, issued on July 10, 2006, in Docket No. 050954-TX. The Final Order approved M.T.G.'s request to pay the \$10,000 penalty imposed in the docket by Proposed Agency Action (PAA) Order PSC-06-0229-PAA-TX (the PAA Order) in 23 equal monthly payments of \$416.67, with final payment of \$416.59. The Final Order required that if M.T.G. failed to timely submit one payment, CLEC Certificate No. 7773 should be canceled.

The first payment was due within 14 days of the issuance of the Final Order, with subsequent payments due on the 15th day of each subsequent month. If the 15th of a given month occurred on a weekend or holiday, the payment would be due on the following business day. Commission records show that the last installment remitted by M.T.G. was received on October 16, 2006. M.T.G.'s next installment was due on November 15, 2006, but was never received. Therefore, M.T.G.'s CLEC Certificate No. 7773 was canceled with an effective date of November 16, 2006.
