AMENDED JOINT MOTION

The Citizens of the State of Florida (“Citizens”), AARP, the Florida Industrial Power Users Group (“FIPUG”), and the Florida Retail Federation (“FRF”), by and through their respective counsels, amend their pending Joint Motion to Reschedule Evidentiary Hearing Or, In the Alternative, to Revise Procedural Milestones of the Order On Procedure (“Joint Motion”), and state:

1. Upon consideration of the current status of their plans to participate in this case, Joint Movants withdraw their request to reschedule the evidentiary hearing in this cause.
2. For the reasons stated in the pleading, Joint Movants confirm and renew the alternative request contained in the Joint Motion, which is to maintain the existing hearing date of August 7, 2007, but extend the deadlines for Intervenor testimony from May 29 until June 19; establish a deadline for Staff testimony of July 5, 2007; set the time for rebuttal testimony as July 19, 2007; and reschedule the Prehearing Conference for a date falling within the week of July 23, 2007.
