



PETITION FOR APPROVAL OF TRANSFER OF CERTIFICATE FROM XSPEDIUS MANAGEMENT COMPANY SWITCHED SERVICES, LLC TO TIME WARNER TELECOM OF FLORIDA, L.P.

COMES NOW Time Warner Telecom of Florida, L.P., (Time Warner Telecom) and petitions for approval of the transfer of certificate #5744 and waiver of Rule 25-4.118, Florida Administrative Code regarding selection of the telecommunications provider and would show the following:

1. Time Warner Telecom, L.P. is acquiring the assets and customer base of Xspedius Management Company Switched Services, LLC (Xspedius) of Florida.

2. Time Warner Telecom, L.P. has filed an application for transfer of the certificate to provide for assignment and transfer of the certificate to Time Warner Telecom.

3. Time Warner Telecom also simultaneously files with this Petition for Waiver a proposed customer notice which will be forwarded to all current customers of Xspedius notifying them of the change and providing an opportunity for a change in providers. The proposed customer notice also provides that the preferred carrier freeze will not be maintained and that a positive action on the part of the customer will be necessary in order to reinstate the preferred carrier freeze. The customer notice has been included with this filing for reference by the Commission.

4. Time Warner Telecom asks that the Commission waive the requirements of Rule 25-4.118, Florida Administrative Code. That rule currently provides that the provider of a customer's local, local toll or toll provider selection shall not be changed without the customer's authorization. Here, the acquisition of Xspedius would change the provider of telecommunication services without the customer's authorization. However, such acquisition and proposal for change provides that no change in rates or terms of service will be made until the expiration of the customer's current contract with Xspedius. Such terms and conditions will be honored by Time Warner Telecom for all Xspedius contracts. The parties to the acquisition ask that the Commission waive the conditions provided in Section 25-4.118, Florida Administrative Code, in order to allow the orderly transfer of all customers of records. The parties have made the necessary filings with the Federal Communications Commission regarding the acquisition and that states such transfer and transitions are in the best interest of the public.

5. The customer notice will be forwarded to all customers and Time Warner Telecom has designated a person to receive complaints from Xspedius customers who may be dissatisfied. That customer contact is as follows:

6. Neither Time Warner Telecom nor Xspedius Communications has any outstanding actions pending against them which would inhibit or prevent the acquisition from proceeding upon approval of the Florida Public Service Commission.

7. Time Warner Telecom has paid all 2006 regulatory assessment fees and will pay all regulatory assessment fees assessed against Xspedius within thirty (30) days of approval of Commission and any necessary computation of the required regulatory assessment fee.

WHEREFORE, Time Warner Telecom asks that the Commission approve the Joint Request for transfer of the certificate, waiver of Rule 25-4.118, Florida Administrative Code, as applicable to this transfer and grant such other and further relief as it may deem appropriate. We are pleased to now inform you that Time Warner Telecom, Inc. is consolidating all of its Florida regulated telecommunications assets into Time Warner Telecom of Florida, L.P., a subsidiary of Time Warner Telecom, Inc. Following this consolidation, Xspedius will no longer provide telecommunications services in Florida. Your transition from Xspedius to Time Warner Telecom of Florida, L.P. for telecommunications services requires no action on your part.

The transfer of your service to Time Warner Telecom of Florida, L.P. will be invisible to you because Time Warner Telecom of Florida, L.P. will utilize the same facilities that currently serve your account. Moreover, there will be no change in the services you have ordered. The transfer of your services to Time Warner Telecom of Florida, L.P. will be seamless and without down time or modification to existing services or rates. This transfer requires no action on your part. The local account team who services your account today will continue to provide you the excellent service that you have experienced to date.

We believe that this new development will be good for your company. The vision, financial capital, and experience of Time Warner Telecom, Inc. will bring our customers innovation and excellent customer service. As your new service provider, Time Warner Telecom of Florida, L.P. will continue to provide you with the same telecommunications services you currently receive in accordance with the rates, terms and conditions of your existing contract or effective tariffs on file with the Florida Public Service Commission. of this letter. You will not incur any charges for the change to Time Warner Telecom of Florida, L.P. However, should you select another provider, you may incur additional charges. If you change providers, the terms and conditions of your Xspedius contract will still apply, including any applicable termination liability or change charges. Please be aware that you are responsible for paying all bills rendered to you by Xspedius during this transition. You may be subject to termination of your service in accordance with the terms of your contract and applicable Commission rules if you fail to pay your telephone bill.
