AMENDMENT TO TAMPA ELECTRIC **COMPANY'S PETITION**

On May 7, 2007 Tampa Electric filed its petition for approval of several service 1. applications relating to installation of underground distribution facilities and customer applications relating to underground service and relocation of facilities including Original Tariff Sheet No. 7.820: Application for Underground Service in an Underground Service Area.

After initial Staff review it was determined that a revision to the description of the 2. customer payment described in Tariff Sheet 7.820 included in the May 7, 2007 filing was necessary to cover a wider range of customer requests.

3. In the first paragraph of Tariff Sheet 7.820 filed on May 7, 2007 the customer's payment is described as "the estimated cost difference between the requested underground service and the overhead service that would otherwise have been installed."

This description has been changed to "the estimated cost of facilities required for 4. the service request that are in excess of those normally provided by the Company." Accordingly, the payment can represent either a differential or an incremental cost depending on the nature of the service request.

5. An unrelated correction was made to the second line of the second paragraph of this same document to eliminate the term "overhead" in reference to company facilities since this application is for use in an existing underground area.

The company requests approval of this application form for inclusion in the standard forms section of the company's tariff. Likewise, the company withdraws the Tariff Sheet 7.820 filed on May 7, 2007.

WHEREFORE, for the reasons stated above, Tampa Electric respectfully requests that the attached Original Sheet No. 7.820 be substituted for the same sheet filed on May 7, 2007 and that the Petition as amended herein be approved.
