On January 9, 2007 audit staff filed an audit report entitled "Verizon Business (Formerly MCI Network Services, Inc.) Regulatory Assessment Fee Audit for the Six Months Ended June 30, 2005." That audit report is held as claimed confidential (Document 00216-07).

On March 6, 2007, Verizon filed a response to the audit challenging the PSC auditors' assessment that the auditors were not able to verify if Regulatory Assessment Fee information filed by Verizon was accurate (Document 02049-07).

In addition on March 6, 2007, Verizon requested a confidential classification for portions of this audit response (Document 02049-07). Verizon's request included a copy of the document with the confidential material highlighted (Document 02049-07) and a public copy with the sensitive information redacted (02047-07).
