

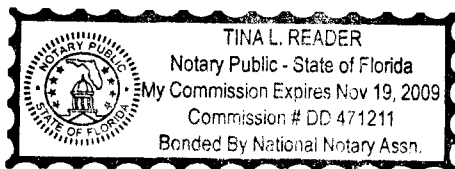

NOTICE OF APPLICATION FOR AMENDMENT TO WATER CERTIFICATE

Notice is hereby given on the 6th day of June, 2007, pursuant to Section 367.045, Florida Statutes, and Section 25-30.030, Florida Administrative Code, of the Application of Aqua Utilities Florida, Inc., 1100 Thomas Avenue, Leesburg, Florida 34748, of its intent to apply to the Florida Public Service Commission to extend its service area to provide water service to the property described below in Lake County, Florida:

A portion of Section 29, Township 20 South, Range 26 East, Lake County, Florida being more particularly described as follows:

Commence at the North 1/4 corner of said Section 29, Township 20 South, Range 26 East; thence run N 88°57'27" W, along the North line of said Section 29 for a distance of 50.00 feet to a point on the West right-of-way line of Monroe Street; thence run S 00°46'56" W a distance of 314.17 feet for a point of beginning; thence continue along said West right of way line, S 00°46'56" W a distance of 958.56 feet; thence N 88°56'15" W a distance of 1917.50 feet to a point on the East right of way line of Adams Street; thence N 00°50'39" E, along said East right of way line a distance of 610.80 feet; thence S 88°58'18" E a distance of 583.71 feet; thence S 00°50'39" W a distance of 33.00 feet; thence S 88°58'18" E a distance of 751.29 feet; thence N 00°48'05" E a distance of 379.37 feet; thence S 88°59'45" a distance of 581.74 feet to the point of beginning.
