Verizon Select Services Inc. ("VSSI"), located at 700 Hidden Ridge, Irving, Texas 75038, hereby withdraws the Section 63.71 Application it filed with the Commission on April 18, 2007. That Application provided notice to this Commission that, on July 1, 2007, VSSI would no longer provide toll-free and outbound long distance services to business customers served by two long distance switches located in Philadelphia and New York City. Verizon is continuing to work with its customers to ensure that acceptable alternative service options are available before proceeding with the discontinuation of these services.


