

**NOTICE OF VOLUNTARY WITHDRAWAL OF JOINT APPLICATION**

Lenvil H. Dicks Utility ("Utility") and the City of Lake City ("City") hereby withdraw their Joint Application for acknowledgement of the sale of the Utility [Certificate No. 391-W] to the City filed on May 17, 2007. On May 3, 2007, the Board of County Commissioners for Columbia County, Florida ("Columbia County Board") adopted Ordinance No. 2007-15 authorizing it to regulate private water, wastewater and effluent reuse utilities seeking to do business in Columbia County. By Resolution No. 2007R-21, dated June 7, 2007, the Columbia County Board approved the sale of the Utility to the City. Because the Columbia County Board has already approved the sale, this matter before the Commission is now moot.
