**JOINT MOTION FOR FINAL EXTENSION OF FILING DATES**

The Greater Orlando Aviation Authority (“GOAA”), Miami-Dade County (the “County”), and BellSouth Telecommunications, Inc. d/b/a AT&T Florida (“AT&T Florida”) (collectively, the “Parties”), by and through their undersigned counsel, hereby submit this Joint Motion for Final Extension of Filing Dates in the above-captioned matter. In support of the Motion, the Parties state:

1. On June 28, 2007, the Commission granted the Parties’ joint motion for an additional extension of the briefing dates to allow for continued discussions of settlement alternatives.
2. Pursuant to the Commission’s Order Granting Joint Motion for Third Extension of Time, Order No. PSC-07-0544-PCO-TL (June 28, 2007), direct briefs are currently due to be filed by the Parties on or before July 9, 2007, and reply briefs are due on or before July 24, 2007.
3. Settlement discussions that had been ongoing between AT&T Florida and the County have recently been terminated. Therefore, the Parties hereby request a final extension of thirty (30) days in which to submit their respective briefs, which would make the direct briefs of all Parties due to be filed at the Commission on August 9, 2007.
4. In addition, in light of pre-existing vacation plans by several of the Parties and their respective counsel, the Parties also request that the time for filing reply briefs be extended


from the current fifteen (15) days to thirty (30) days, which would make the reply briefs of all Parties due to be filed at the Commission on September 10, 2007.

**WHEREFORE**, the GOAA, the County, and AT&T Florida respectfully request that the Commission grant the Parties a final extension of the filing date in this matter so that initial briefs are due on August 9, 2007 and reply briefs are due on September 10, 2007.




