By Order No. PSC-05-0143-PAA-SU, issued February 7, 2005, the Commission approved a settlement that required North Peninsula Utilities Corporation (NPUC), to refund 1.56% of all revenues collected from the implementation of the utility's last index in August of 2002 through September 5,2003, to refund 7.09% of revenues collected from September 5,2003 through the date of implementation of reduced rates, and to reduce all categories of rates by 2.37% on a going-forward basis. This order further stated that the docket shall be closed administratively once staff verified that NPUC completed the required refunds.


