Dear Mr. Ferrelli:

There are two types of cancellation. One is voluntary, which is when a certificate is cancelled at a certificate holder's request and the company has paid all applicable Regulatory Assessment Fees. The other is involuntary and is when a certificate is cancelled on the Commission's own motion for a rule, statute, or order violation. Since the Regulatory Assessment Fee is applicable if a certificate is active for any day during a calendar year and because the letter you attached requesting cancellation is dated March 1, 2007, this means that the 2007 fee is applicable and must be paid in order to be granted a voluntary cancellation.

I will open a docket to cancel your certificate with an effective date of December 20, 2007. A recommendation will be filed to deny American Telecharge, Inc. a voluntary cancellation and instead, cancel the certificate on the Commission's own motion. The order cancelling the certificate will have a statement that provides if the 2007 fee is paid before the end of the protest period, the cancellation will be considered voluntary. Any unpaid fees will be turned over to collections.

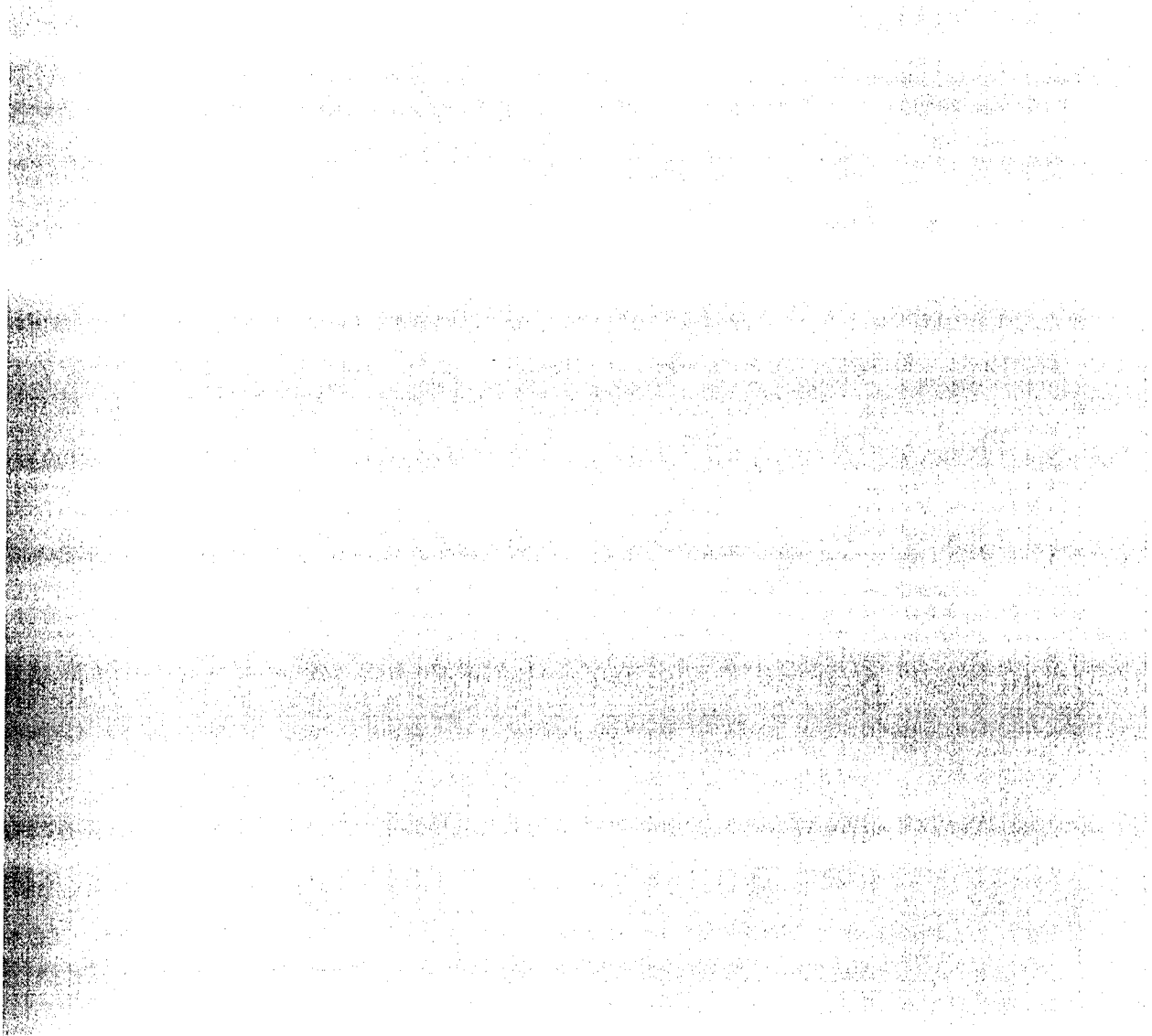
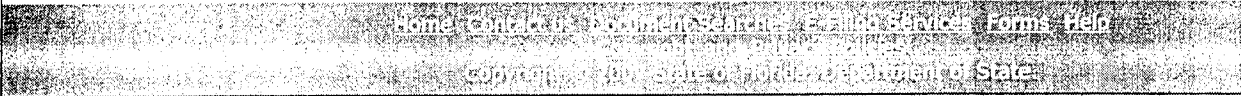


