After reviewing the customer deposit rule, the Utility is in agreement that the deposit should not have exceeded \$104.0. Therefore the Utility will credit Mr. Will's bill the amount of \$37.00 towards his next bill. The Utility does agree that the Tariff states that if both water & wastewater service is provided, only a single charge is appropriate. However the Utility disagrees that the charge should only be \$15.00 for two reasons, 1) the Waste water tariff states actual cost & 2) there were mulitple actions taken as there were more then one premises visit as well as several meetings with Mr Will at his request. Therefore the utility is not in agreement with the staffs assessment.
