Dear PSC friends Lisa, Matthew, Katrina, Nancy, Nathan:

RE: Docket No.070602-EL, ORDER NO. PSC-08-0021-FOF-EI, ISSUED January 7, 2008

I was not able to download the Public Comment Card but must ask that you take this as my **firm objection** to expand Turkey Point and St. Lucie nuclear power plants, to exempt these plants from Bid Rule 25-22.982, FAC and request you not allow cost recovery through the Commission's Nuclear Power Plant Cost Recovery Rule, Rule 25-6, 0423, FAC.

The basis for my objections is similar to that of my objection to building new reactors at this site - increased nuclear production in this area will add to water and hazardous nuclear waste woes already problematic.

It will increase the likelihood of nuclear attack, having a larger target. And, of great importance, it would be impossible to evacuate Miami area in the event of a nuclear meltdown or other threat. You might try consider that while traveling home tonight from that meeting during Friday rush hour.

The most urgent need for us to spend limited energy \$\$ resources on doable Solar and Wind energy is being shoved aside to invest more in hazardous nuclear energy in a very costly and hazardous location.

In all regards, including the financial and human factors and to protect our national defense, we must scale back, not uprate, nuclear energy in Florida. We must insist on REAL change in the form of more wind, SOLAR NOW, geothermal, wave and other renewables.

Nuclear is not an option. Remember 3 Mile Island. Keep in mind that we cannot even avoid a disaster with a construction crane in Miami. How can we ever hope to wrap ourselves around expanding nuclear when we should be phasing it out as quickly as possible? Maybe then we can begin to deal with the thousands of years depleted nuclear will remain under the skin of the earth, like tumors under the "Mother".

Lew Hayes of FPL today on his talk to Shareholders even said, "....I am honestly scared to death of nuclear." I couldn't agree more, whether he was just talking about money or the cost to the planet.

I heard much from FPL today in the way of lip service to solar. Either Jim or Lew said that they feel solar will be the next wave of energy within 5 years...with nothing about real solutions being implemented along those lines. I request the PSC say "NO" to any further nuclear development and get busy on truly cost-effective solutions like solar.

3. As individual citizens and tax payers of the United States who reside in the area and would be immediately affected by the decision of Docket # 070602 and their respective organization who are comprised of participants in the same category. The Petitioners health and well-being as well as other substantial interests will be affected.
4. The petitioners are concerned about issues regarding public input based on the decision on the matter of Docket# 070602, expanding FPL nuclear power facilities of Turkey Point and Hutchinson Island, which was not scheduled to have a final order until February 18, 2008.
5. Peitioners believe that health effects and economic impacts related to these expansions have not been sufficiently reviewed for approval.
