

**AT&T FLORIDA’S NOTICE OF WITHDRAWAL OF NOTICES OF INTENT TO REQUEST SPECIFIED CONFIDENTIAL CLASSIFICATION**

BellSouth Telecommunications, Inc. d/b/a AT&T Florida (“AT&T Florida”), by and through its undersigned counsel, respectfully files this notice withdrawing its Notices of Intent to Request Specified Confidential Classification (“NOI”) and states the following:

1. On February 7, 2008, AT&T filed a NOI for Exhibit No. MP-1 to Marc W. Potteiger’s Direct Testimony which it contained Thrifty Call, Inc.’s (“Thrifty Call”) “confidential” information. Pursuant to the Rules, a Request for Specified Confidential Classification (“RCC”) needs to be filed within 21 days in order to keep the confidential information protected. This RCC would have been due on or about February 28, 2008.
2. On February 14, 2008, AT&T filed a NOI for its Responses to Thrifty Call’s First Request for Production of Documents Nos. 1, 2, 5, 7 and 8 which also contained Thrifty Call’s “confidential” information. Pursuant to the Rules, this RCC would have been due on or about March 6, 2008.
3. On February 15, 2008, AT&T Florida forwarded correspondence to Thrifty Call’s Counsel notifying Thrifty Call of the due dates for the RCCs and advising that AT&T Florida did not intend to file the RCCs, as the information filed under the above-referenced NOIs was Thrifty Call’s information.

4. On or before the RCC's due dates, Thrifty Call did not file the appropriate RCCs to protect its information.

5. Accordingly, based upon the foregoing, AT&T Florida withdraws its NOIs dated February 7, 2008 and February 14, 2008.


