(PEF) for a determination of need for proposed nuclear power plants in Levy County, together with the associated facilities, including transmission lines and substation facilities, needed to integrate the proposed units with PEF's transmission network for delivery of electrical power to its customers. PEF's proposal consists of two nuclear generating units, which will contribute approximately 2,184 megawatts (MW) of new generation. Levy Units 1 and 2 are each expected to be 1,092 MW (summer rating), advanced passive light water nuclear reactors. The proposed in-service dates for the units are 2016 and 2017. This matter has been assigned Commission Docket No. 080148-EI.
