BY THE COMMISSION:

By letter dated December 12, 2007, Payphones Plus, Inc., holder of Pay Telephone Certificate of Public Convenience and Necessity No. 4474, requested that Certificate No. 4474 be amended to reflect the new corporate name, Payphones Plus Plus, LLC. Upon review of the Department of State, Division of Corporations' records, it appears that Payphones Plus, Inc. has properly registered the new corporate name. Accordingly, we find it appropriate to amend Certificate No. 4474 to reflect the new corporate name.

This Order will serve as the amended Certificate of Public Convenience and Necessity No. 4474 for Payphones Plus Plus, LLC. Payphones Plus Plus, LLC should retain this Order as evidence of the name change. We are vested with jurisdiction over this matter pursuant to Section 364.335, Florida Statutes.
