**PETITION FOR APPROVAL OF ENVIRONMENTAL COST RECOVERY  
TRUE-UP FOR THE PERIOD ENDING DECEMBER 2007**

Florida Power & Light Company ("FPL") hereby petitions this Commission for approval of FPL's actual End-of-Period Environmental Cost Recovery Clause ("ECRC") true-up over-recovery amount of \$2,588,553 for the period January 2007 through December 2007 and an over-recovery of 3,174,379 as the adjusted net true-up amount for the same period. In support of this Petition, FPL states as follows:

1. The actual End-of-Period ECRC true-up over-recovery of \$2,588,553 for the period January 2007 through December 2007 was calculated in accordance with the methodology set forth in Schedule A-2 for the Fuel Cost Recovery Clause, attached to Order 10093 dated June 19, 1981. This calculation and the supporting documentation are contained in the prepared testimony and exhibit of FPL witness K.M. Dubin, which is being filed together with the Petition and incorporated herein.

2. In Order No. PSC-07-0922-FOF-EI, dated November 16, 2007, the Commission approved an under-recovery of \$585,826 as the estimated/actual ECRC true-up for the period January 2007 through December 2007.

3. The adjusted net true-up for the period January 2007 through December 2007 is an over-recovery of \$3,174,379, which is the difference between the actual true-up over-recovery of \$2,588,553 and the estimated/actual true-up under-recovery of \$585,826.


