NuVox Communications, Inc. ("NuVox") hereby files its response to Staff's 2008 Local Competition Data Request, and requests confidential classification for certain portions thereof pursuant to Section 364.183(1), Florida Statutes.

Pursuant to Rule 25-22.006(5), F.A.C., enclosed please find two copies of NuVox's public responses and a sealed envelope marked "CONFIDENTIAL" which contains one copy of NuVox's confidential responses as well as a confidential CD with corresponding confidential files. As required by Rule 25-22.006(5), Florida Administrative Code, confidential information in the paper documents has been highlighted, while such information has been redacted from the public responses. Confidential information in the data files on the CD has been highlighted where permitted by file restrictions. In addition, however, the CD contains files where this function was not available due to file restrictions and thus NuVox considers the entire CD to be confidential.
