On February 27, 2008, AT&T Florida filed a Notice of Intent to Request Specified Confidential Classification of its response to Thrifty Call's Second Set of Production of Documents (PODs) Numbers 9, 11, 13, and 14 in Document No. 01464-08.

On March 13, 2008, a more readable copy of AT&T's response to POD 11 was provided (Document No. 01901-08) and was protected under the previous Notice of Intent for Document No. 01464-08.

On March 19, 2008, AT&T Florida filed its Request for Specified Confidential Classification for only two pages of its response to POD 14 in Document No. 01464-08 with a second copy of the two pages provided in Document No. 02065-08. AT&T Florida withdrew its Notice of Intent for its response to POD 11 which was subsequently declassified in Document Nos. 01464-08 and 01901-08.

AT&T Florida stated that it would not be filing a Request for its responses to PODs 9 and 13 and that Thrifty Call had been notified of the Request due date. Since 21 days had expired from the filing of the Notice of Intent, on April 9, 2008, AT&T Florida's responses to PODs 9 and 13 were declassified.

Technical staff requests that an order be issued granting confidentiality to the first two pages of AT&T Florida's response to POD 14, Inter-LATA/Inter-state IXC Tests, in Document No. 01464-08 and the two pages of Document No. 02065-08 because they contain confidential competitive business information and meet the requirements of Section 364.183, Florida Statutes. Technical staff recommends that the remaining pages of POD 14 in Document No. 01464-08 be declassified as they contain information from test calls.
