Pursuant to Section 366.093 of the Florida Statutes and Rule 25-22.006 of the Florida Administrative Code, Florida Power & Light Company ("FPL") hereby files its Notice of Intent to Seek Confidential Classification of Exhibit SDS-4 to the pre-filed testimony of FPL witness Steven Scroggs that is being filed in support of FPL's contemporaneous cost recovery petition in this docket.


