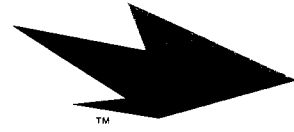

SCR Embarq considers the highlighted information confidential because it contains the number of
SGA residence and business access lines by Retail, Resale and UNE-P. Competitors can use this
SEC information to gauge market share. In addition, Embarq is required by its Interconnection
OTH Agreements (ICA) as well as Section 222 of the Communications Act to protect the confidentiality
 of proprietary information of and relating to its wholesale customers.
