Re: Docket No. 070739-WS, Application for approval of transfer of Fairways/Mt. Plymouth, Ltd.'s water and wastewater systems to Aqua Utilities Florida, Inc. and for amendment of Certificate Nos. 206-W and 120-S in Lake County.

Dear Mr. Hoffman & Ms. Rule:

Listed below are the modifications to Aqua Utility Florida, Inc.'s (AUF's) tariffs necessary to accommodate the above referenced transfer. Marked tariff sheets reflecting the modifications are enclosed for reference. In recent discussions with Troy Rendell, it was decided that the name of the acquired system should be shortened to "Fairways." Therefore, all tariff sheets filed as revised Exhibit P on February 27, 2008, will need to be changed to reflect the shortened name. Other modifications are needed to the February 27, 2008, tariff filing along with modifications to unfiled tariff sheets. The list of tariff sheets below includes all needed modifications. The revision levels are after modification.

To continue to keep the systems alphabetically within the County listings in Section II of the tariffs, it was necessary to renumber some of the other systems. Another approach would be to add new systems like Fairways non-alphabetically at the end of the County listings. Because of issues like this, as well as the complexity of AUF's tariffs, it would be helpful to have someone within the Company designated to oversee all tariff revisions. Staff would be happy to meet with someone from the Company to discuss these issues.
