



CUSTOMER NOTICE

ISSUED: June 18, 2008

On January 7, 2008, Continental Utility, Inc. (the "Utility"), completed its application to the Florida Public Service Commission (the "Commission") for increased wastewater service rates, in which it requested a wastewater rate increase of 21.08%.

By Proposed Agency Action (PAA) Order No. PSC-08-0334-PAA-WS, issued May 27, 2008 ("PAA Order"), the Commission approved a wastewater rate increase of 20.25%. These rates and charges are designed to allow the Utility the opportunity to recover the costs for collection system rehabilitation, and a reasonable rate of return on its investment in facilities necessary to provide such wastewater service.

The increased rates and charges are effective for service on or after June 23, 2008.
