CUSTOMER NOTICE OF IMPLEMENTATION OF IRRIGATION RATE INCREASE

ISSUED: June 16, 2008

By Final Order No. PSC-07-0529-AS-SU, issued June 26, 2007, the Florida Public Service Commission approved a change in Alafaya Utilities, Inc.'s rate structure for billing for reuse irrigation service from a flat rate to a rate based upon the amount of irrigation water used. This change in billing structure required the installation of water meters on each customer's irrigation line. A notice was sent to you last year that upon installation of the irrigation meters the new billing structure would be effective. Since all meters have been installed on irrigation lines, this notice is a reminder that Alafaya Utilities, Inc., will begin billing based upon consumption as reflected by the meter reading. This change will be reflected in your June 2008 bill.

The irrigation rates prior to filing, the Commission-approved interim rates, and the newly implemented rates appear below. Should you have any questions contact our office at 407-869-1919.
