**AMENDMENT TO PETITION OF FLORIDA PUBLIC UTILITIES COMPANY  
FOR APPROVAL OF MID COURSE CORRECTION**

Florida Public Utilities Company (“FPUC”), by the undersigned, herewith files this Amendment To Petition for Approval of Mid Course Correction filed June 13, 2008, and would state:

1) On June 13, 2008, FPUC filed a Petition for Approval of Mid Course Correction seeking an adjustment to the purchased power recovery factor for both the Northwest and Northeast Divisions. The calculations and requested revised purchased power factors are reflected in the testimony and schedules attached to the Petition. The purpose of this Amendment to the Petition is to clarify the requested factor for the Northeast Division.

2) In the Northeast Division, the purchased power recovery as of the end of July 2008, as reflected on Schedule F-1 filed with the Petition is an overrecovery of \$206,038 which results in an adjustment of -0.16302 to the current factor if this were the final true-up. However, pursuant to the Purchased Power Agreement with JEA, there is an increase in the purchased power cost to be paid to JEA for purchased power by FPUC such that FPUC projects an underrecovery of \$1,843,597 as of year end 2008. As reflected in the testimony of Mr. Mark Cutshaw and Schedule E-1 which accompanied the filing, the requested factor for the Northeast Division is 5.647 cents per kWh. The

calculation of the projected factor incorporates the -0.16302 cents per kWh for the overrecovery through June, 2008.

3) FPUC would amend its Petition to the extent necessary to reflect this clarification and incorporates herein the Petition as initially filed with this clarification. FPUC requests the Commission approve the revised fuel factors as presented by the company.


